The modern healthcare landscape is challenging. Fewer providers are choosing to practice in rural communities. An increasingly fragmented care landscape is often low-quality, inequitable, and competitive with local healthcare. We are rethinking the delivery of pediatric care in Montana in ways that improve the lives of Montana's children, decrease the cost of medical care for families, and support our state's own primary care providers.

priorities and impacts



access & equity: provide access to high-quality, low-cost pediatric-specific care for all children in Montana regardless of their geographic location or family's ability to pay.



a connected infrastructure: grow and maintain a collaborative network of care for every pediatric provider in Montana to feel supported by their peers, and a technological backbone that enables information and services to flow seamlessly and proactively across traditionally competitive health systems despite inherent barriers caused by increased fragmentation.



sustainability and scalability: uphold the resilience of Montana's healthcare economy with programs that embody our mission, are financially sustainable, and are relevant to diverse communities and provider needs.

programs



after-hours on-demand care

Our collaborative call pool provides access to pediatric care on-demand without compromising convenience or continuity while also improving our providers' worklife balance by reducing the need to be on-call any given night or weekend.

- Established an easy-to-use financial aid fund to ensure every child in Montana can access care regardless of their geographic location or family's ability to pay.
- Received a \$1M grant from the Dennis and Phyllis Washington Foundation in 2023 to expand access to on-demand care.
- In 2024, will be debuting the Montana Pediatrics At-Home project, supporting Montana's most rural families with diagnostic and care tools to enhance their ability to care for their children without leaving home.



rural complex care coordination

We are working side-by-side with families, social workers, providers, and researchers to address the greatest challenges for children and youth with special healthcare needs living in a rural state.

- Selected in 2022 by HRSA as one of five demonstration sites nationwide, in partnership with the University of Montana, to develop enhanced systems of care for children with medical complexity.
- This year, we will work with families to ensure even the most complex children can benefit from virtual-based care, and begin testing a pilot care coordination program for families of children with medical complexity.



families in crisis & transition

In partnership with organizations that provide social safety net services like housing, relief from domestic violence, and youth mentoring, we support families wherever they are with access to pediatric care unbound by the barriers that transportation, appointment times, and the ability to pay often have against obtaining in-person clinical care.



pediatric mental health

In response to Montana's childhood mental health crisis, we are piloting a new program that offers virtual interventions while prioritizing existing relationships between families and their child's usual place of care.

- Engaged with representatives from 15 agencies and organizations in spring 2023 to understand the pediatric primary care landscape and contribute to the development of a new integrated behavioral health pilot.
- Partnered with rural health clinics on the Hi-Line and tribally-led school based health clinics to begin seeing the first patients of an initial pilot program.
- In 2024 we will expand our pilot program to include medication management, interprofessional consultations, virtual integrated behavioral health, and single digital interventions.



type 1 diabetes support and data management

By partnering on data-driven initiatives for advancing care and supporting school health personnel with customized, diabetes-specific education, we are working to positively impact the diagnosis and care experience for Montana's children with Type 1 Diabetes and their families.

- Launched a Diabetes In School Health (DiSH-MT) program that has formulated a network of more than 100 school health personnel, facilitating stronger support between care teams and students with Type 1 Diabetes.
- In 2024, we will bring cutting-edge technology to support families of children with Type 1 Diabetes and continue working with the State of Montana on solutions that better facilitate quality care between students, families, and their care teams.



rural & urban indigenous partnerships

We have been invited to work hand in hand with four tribal health programs to provide culturally informed, quality, and accessible care for many of Montana's most vulnerable communities. Our work so far includes general pediatrics as well as neurology, cardiology, psychiatry, counseling, and nutrition.
